DETERMINATION OF REGISTRATION FEES

Instrument No. 180 of 1998

EXPLANATORY STATEMENT

This determination revokes Instrument No 251 of 21 November 1997 and notified in Gazette No. S358 of 21 November 1997.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of reducing the additional fee payable for short term registrations of motor vehicles and the relevant Road Rescue Fee. This results from the Government's decision to introduce three monthly registration periods for all vehicles.

The majority of fees remain the same. Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to vehicle registration. This instrument commences operation on 1 August 1998.
