## AUSTRALIAN CAPITAL TERRITORY TRADE MEASUREMENT (ADMINISTRATION) ACT 1991 DETERMINATION OF FEES

NO 271 OF 1997

## **EXPLANATORY STATEMENT**

The Trade Measurement (Administration) Act 1991 provides for the administration of the Trade Measurement Act 1991 and related matters concerning "trade measurement legislation" Trade measurement legislation is defined in section 3 of the Trade Measurement (Administration) Act 1991 as including the Trade Measurement (Administration) Act 1991, Trade Measurement Act 1991, the Weights and Measures (Sale of Bread) Act 1929, and regulations made under these Acts

Section 12(1) of the Trade Measurement (Administration) Act 1991 enables the Minister to determine fees for the purposes of trade measurement legislation

This Determination revokes Determination of Fees No 204 of 1996 and notified in the Asutralian Capital Territory Gazette No S236 of 11 September 1997 and determines that the various fees payable under the Act shall be as set out in the Schedule to the Determination

Section 12(1) of the Trade Measurement (Administration) Act 1991 enables the Minister to determine fees for the purposes of trade measurement legislation. The fees have generally been increased by a margin of 1.75% in accordance with the anticipated movement in 1997/98 of the Consumer Price Index Fees for items 1, 2, 3, 4, 17 and 18 (c) have not been increased because of rounding
