# **REVOCATION AND DETERMINATION OF FEES**

# EXPLANATORY STATEMENT

#### Instrument No. 168 of 1998

This Determination made under section 52A of the Surveyors Act 1967 (the Act) revokes the existing Determination of Fees and sets the fees for the purposes of the Act.

The fees for Registration under section 19 of the Act and regulations 27, 28 and 29 of the Surveyors Regulations have increased significantly from July 1997. These increases are as a result of an agreement between the ACT and NSW Governments. The ACT and NSW Surveyors Boards have identified a number of areas where greater cooperation and joint activity will produce efficiencies and cost savings. One of these areas is the annual registration of surveyors. As most surveyors work in the ACT and the surrounding areas in NSW, there is a need to be registered in both juristrictions. A joint registration procedure has been negotiated which will simplify administration and enable joint fees to be charged.

The fee for annual registration increases from \$168 to \$275. A new fee of \$400 has been introduced to cover registration in both the ACT and NSW juristrictions. The initial registration fee also increases from \$230 to \$338. This initial fee contains an administrative component.

The net result will be an increase in revenue for the ACT, a slight reduction in revenue for NSW, and an administrative saving for both Boards, and a fee saving for joint registrants.

The remaining fees have increased as a result of CPI adjustments in accordance with Government policy.
