## **DETERMINATION OF FEES**

### NO. 251 OF 1997

### **EXPLANATORY STATEMENT**

This determination revokes Determination No 245 of 4 November 1997 and notified in Gazette No. S338 of 4 November 1997.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the Road Transport Charges (Australian Capital Territory) Act 1993 (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of amending the fee to be charged for inspections of motor vehicles exceeding 4.5 tonnes GVM.

Determination No. 245 of 4 November 1997 set the inspection fee for heavy motor vehicles at \$99. Following promulgation of that fee the Government agreed to the establishment of a working party to further consider safety and registration issues affecting heavy vehicles including appropriate inspection fees. This Determination resets the inspection fee for heavy motor vehicles to the previously determined fee of \$34 until the outcomes of that working party are finalised.
