DETERMINATION OF FEES

INSTRUMENT NO 245 OF 1997

EXPLANATORY STATEMENT

This determination revokes:

- Determination No 128 of 24 June 1997 and notified in Gazette No. S194 of 27 June 1997; and
- Determination No 53 of 24 March 1997 and notified in Gazette No. S78 of 27 March 1997.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of introducing some new fees for transactions relating to the implementation of the Motor Traffic (Amendment) Act (No 3) 1997 (introduction of competition into vehicle inspection services).

In order to offset some of the costs of administering the new arrangements for inspection of vehicles, application fees for the granting and renewal of appointments and approvals as set are required as the administration tasks remain constant, irrespective of the number of inspections performed by an individual or premises. The fee payable by proprietors of authorised premises for each motor vehicle or trailer inspected is required to offset the costs for the audit function for the new arrangements.

Inspection fees have been reduced, except for motor vehicles in excess of 4.5 tonnes GVM, to be in line with the inspection fees to be charged by approved authorised premises. The new fees were agreed to by Government in April 1997.

Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to vehicle registration.
