

**AUSTRALIAN CAPITAL TERRITORY  
VOCATIONAL EDUCATION AND TRAINING ACT 1995  
DETERMINATION OF FEES**

**Instrument No. 147 of 1998**

**EXPLANATORY STATEMENT**

The Vocational Education and Training Act 1995 commenced operation on 1 January 1996. The Act provides for planning, funding, co-ordination, evaluation, regulation and promotion of vocational education and training in the ACT.

Section 67 of the Act provides for fees to be determined for the purposes of the Act.

The fees for 1998-99 have increased from the existing 1997-98 fees by the Consumer Price Index at 2.5% as advised by the Office of Financial Management.

**Articulated Training Program**

These are three bands of qualifications-Certificates, Diplomas and Degrees. There is provision to separately accredit each qualification band within a single application. The fee reflects the reduced amount of work to accredit each band of qualification during the one accreditation process.

**Re-accreditation of award** is adjusting and renaming a number of courses.

**Short Courses** are recognised qualifications that do not address all the requirements for a full certificate qualification. These are small number of specialised modules grouped together to meet industry training needs.
