

MOTOR OMNIBUS ACT 1955

EXPLANATORY STATEMENT - DETERMINATION OF CHARGES

INSTRUMENT NO. 229 OF 1997

The Motor Omnibus Act 1955 governs the operation of motor omnibus services in the ACT. In particular, Section 4 of the Act deals with the determination of charges.

This instrument revokes the previous Instrument No 141 of 1996 dated 3 July 1996 and notified in Gazette No S156 That instrument determined charges for the range of services provided

No changes have been made to existing fares specified in Instrument No 141 Attachment A is a comparative list of the old fares including the new fare

This instrument provides for the introduction of a new off-peak \$1 cash fare that applies within 3 kilometres of the City. This instrument restates the existing fares structure and includes the new \$1 fare

The new fare is specified in bold at 1 (c) (i) in the attachment
