**REVOCATION AND DETERMINATION OF FEES**  
**Instrument No. 136 of 1998**  
**EXPLANATORY STATEMENT**

The Nature Conservation Act 1980 ('the Act') protects native flora and fauna in the ACT, allows for the monitoring of the trade in native and exotic species of flora, fauna and fish and allows for the regulation of activities in reserves and wilderness areas

Under section 83A of the Act the Minister may determine fees. This Instrument revokes the existing Determination of Fees and sets fees for the grant of licences under the Act. Fees payable under the Act have been reviewed and increased in line with the Consumer Price Index or to a level that enables recovery of administrative costs associated with the issuing of a licence. The 1997 fees replaced by this instrument are in brackets.
