DETERMINATION OF FEES

Instrument No. 133 of 1998

EXPLANATORY STATEMENT

This determination revokes Determination No 123 of 1997 dated 24 June 1997 and notified in the Gazette No S194 of 27 June 1997

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees for vehicle licences and permits. Set out below are the new fees (and previous fees) which apply to transactions relating to vehicle licences and permits.

The majority of fees have increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1998-99 budget strategy of the Government and will take effect from 1 July 1998.
