DETERMINATION OF FEES

Instrument No. 126 of 1998

EXPLANATORY STATEMENT

This instrument revokes all existing fees determined under the Cemeteries Act 1933, namely

**Determination of Fees Notice No 126 of 1997 published in Gazette
No S144 of 27 June 1997**

This determination sets fees for the purpose of the Cemeteries Act 1933 and has the effect of re-determining existing fees and determining fees for new services provided by the Canberra Public Cemeteries Trust on and after 1 July 1998

The fees payable are set out in the schedule to the instrument

Fees have been increased in line with the CPI and to effect full cost recovery for the provision of services. Fees are similar to those charged in the States for like services. 1997/98 fees have been carefully examined and every effort made to put the 1998/99 fees in as logical and simple format as possible.

The fees payable are set out below with the corresponding 1997/98 fees shown in *italics*

RESERVATION FEES

A Certificate of Reservation can be purchased entitling the Certificate Holder to an Exclusive Right of Burial at some time during the next 25 years. At the time of purchasing the Certificate, the relevant fees must be pre-paid.

Reservation of an un-specified allotment, or the adjacent allotment at the time of a burial (limit of one allotment paid for within one month at time of burial)

No Premium Fee

Reservation of a Specific Allotment

Reservation Fee + 50% of relevant allotment fee

Certificates of Reservation are renewable but will lapse if not renewed prior to the expiration of tenure
