## MOTOR TRAFFIC ACT 1936

### DETERMINATION OF FEES

NO 42 OF 1995

#### EXPLANATORY STATEMENT

This instrument revokes all existing fees determination under the *Motor Traffic Act 1936*, namely;-

Determination No 65 of 4 June 1994 published in the ACT Gazette No. S126 of 27 June 1994; and

Determination No. 2 of 14 December 1994 published in ACT Gazette No. S7 of 6 January 1995.

The Determination sets fees for the purpose of the Motor Traffic Act 1936 and has the effect of increasing fees payable for transactions which relate to vehicle registration. Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to vehicle registration.

The majority of fees have increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1995-96 budget strategy of the Government and will take effect from 1 July 1995.
