EXPLANATORY STATEMENT

This instrument revokes all existing fees determination under the Motor Traffic Act 1936, namely;-
Determination No 126 of 1994 of 16 August 1994 published in the ACT Gazette No. S183 of 30 August 1994

The Determination sets fees for the purpose of the Motor Traffic Act 1936 and has the effect of increasing fees payable for transactions which relate to number plates. Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to number plates.

The majority of fees have increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1995-96 budget strategy of the Government and will take effect from 1 July 1995.

Application fee for the approval, by the Registrar, of a proposed assignment of a right under Section 26Q for a prescribed right:

custom plates for motor vehicles (excluding motor cycles) where the number is:
