**DETERMINATION OF FEES**

**INSTRUMENT NO. 76 OF 1998**

**EXPLANATORY STATEMENT**

This instrument revokes the previous determination under the *Agents Act 1968* (No. 62 of 1997 notified in ACT Gazette No. S95 of 15 April 1997) relating to fees payable in respect of the issue and renewal of licence and registration fees for real estate agents, stock and station agents, business agents and travel agents.

Increases are based on a 1.8% CPI adjustment for 1998/99. Fees involving licences under section 54A, together with registration fees under section 41A, have been increased by 1.8% and rounded up to the nearest five dollars. Fees payable for miscellaneous services [section 110 and sub-sections 93(6) and 93(11)] have been increased by 1.8% and rounded up to the nearest dollar or five dollars, as appropriate.

This instrument (copy attached) sets fees for the purpose of the *Agents Act 1968* including:

- . annual fees payable by a real estate agent, stock and station agent, business agent or travel agent to be paid in respect of a company as well as an individual;
- the payment of fees where a travel agent elects to increase the number of places of business; and
- . the payment of a fee for the issue of an amended licence.

The fees are set out below, with previous rates shown in brackets.
