EXPLANATORY STATEMENT

This instrument revokes the previous determination under the Agents Act 1968 (No 70 of 1996 notified in ACT Gazette No S92 of 17 May 1996) relating to fees payable in respect of the issue and renewal of licence and registration fees for real estate agents, stock and station agents, business agents and travel agents

Increases are based on a 1 75% CPI adjustment for 1997/98 Fees involving licences under section 54A, together with registration fees under section 41A, have been increased by 1 75% and rounded to the nearest dollar Fees payable for miscellaneous services [section 110 and sub-sections 93(6) and 93(11)] have been increased by 1 75% and rounded to the nearest ten cents, with a minimum increase of five cents in any case

This instrument (copy attached) sets fees for the purpose of the Agents Act 1968 including

annual fees payable by a real estate agent, stock and station agent, business agent or travel agent to be paid in respect of a company as well as an individual,

the payment of fees where a travel agent elects to increase the number of places of business, and
