DETERMINATION OF FEES

NO. 125 OF 1997 EXPLANATORY STATEMENT

This determination revokes Determination No 116 of 1996 of 19 June 1996 and notified in the Gazette No. S144 of 27 June 1996.

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees for drivers' licences. Set out below are the new fees (and previous fees) which apply to transactions relating to drivers' licences.

The majority of fees have increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1997-98 budget strategy of the Government and will take effect from 1 July 1997.
