DETERMINATION OF FEES

INSTRUMENT NO. 203 OF 1997

EXPLANATORY STATEMENT

The Associations Incorporation Act 1991 governs the incorporation of associations in the Australian Capital Territory in particular, section 126 enables the Minister to determine fees for the purposes of the Act and section 125 specifies matters in the Act for which a determined fee is payable.

This Determination revokes Determination of Fees No. 235 of 1996 made on 16 October 1996 and notified in the Australian Capital Territory Gazette No S271 of 22 October 1996 and determines that the various fees payable under the Act, including fees for lodging for registration and searching documents, shall be as set out in the Schedule to the Determination. A statement of the old and new fees is attached.

The fee for Item 1 has been increased by a margin of 1.75% in accordance with the anticipated movement in 1997/98 of the Consumer Price Index and with a view to full cost recovery. The fees for other Items have not been increased as the CPI adjustment is less than 50 cents.
