EXPLANATORY STATEMENT

This instrument revokes all existing fees determinations under the *Motor Traffic Act 1936*, namely -

Determination No 120 of 1 September 1993 published in the ACT Gazette No S185 of 9 September 1993

This determination sets fees for the purpose of the *Motor Vehicles (Dimensions and Mass) Act 1990* and has the effect of increasing dimension and mass permit fees for heavy vehicles effective on and from 1 July 1994. The fees are set out below, with previous fees shown in brackets
