DETERMINATION OF FEES

DETERMINATION NO. 63 OF 1994

EXPLANATORY STATEMENT

This instrument revokes the following fee determinations under the Motor Traffic Act 1936, so far as they relate to the car parks listed below.

Determination No 36 of 24 June 1991 published in the Australian Capital Territory Gazette No. S56 of 1 July 1991;

Determination No 93 of 29 June 1993 published in the Australian Capital Territory Gazette No. S127 of 1 July 1993; and

Determination No 169 of 9 December 1993 published in the Australian Capital Territory Gazette No S261 of 13 December 1993.

This instrument sets charges for the purposes of Section 163C(2) of the Motor Traffic Act 1936 relating to the car parks listed below. The fees reflect the 1994-95 budget strategy of the Government and will take effect from 1 July 1994. Previous fees payable are shown in brackets.

The fee charged for parking a motor vehicle in those areas designated as available for periods not longer than four hours shall be at the rate of 10 cents per 15 minutes for the first two hours, at the rate of 10 cents per 10 minutes for the third hour, at a rate of 10 cents per 7 minutes and 30 seconds for the fourth hour.
