REVOCATION AND DETERMINATION OF FEES

DETERMINATION No. 86 of 1994

EXPLANATORY STATEMENT

Section 40A of the Dog Control Act 1975 ('the Act') empowers the Minister to determine fees for the purposes of the Act.

This determination revokes the existing Determination of Fees and sets fees for:

- . registration of a dog;
- . replacing a tag or certificate of registration;
- . licence for keeping more than three dogs;
- . licence for keeping a dangerous dog;
- . return and transport of a dog impounded under the Act;
- . providing a certified copy of a certificate of registration;
- . viewing the register; and
- . impounding a dog.

Fees payable under the Act have been reviewed and increased generally in line with the Consumer Price Index. Where a new charge has been determined this is noted in the table.

The fees are set out below, the amounts in brackets are the previous fees.

The fee for renewal of a licence to keep a dangerous dog is 105.00 (100.00)

The fee for return of an impounded dog seized by an inspector shall be:		
(a) if the period that has elapsed since the dog was seized does not exceed 24 hours;	50.00	(50.00)
(b) if that period exceeds 24 hours but does not exceed 48 hours;	75.00	(75.00)
(c) if that period exceeds 48 hours but does not exceed 72 hours;	100.00	(100.00)
(d) if that period exceeds 72 hours but does not exceed 96 hours;	125.00	(125.00)
(e) if that period exceeds 96 hours but does not exceed 120 hours;	150.00	(150.00)
(f) for holding a dog at a keeper's request for each period of 24 hours or part thereof	25.00	(25.00)
The fee for transport of a dog is	30.00	(30.00)
The fee payable by the former keeper of a dog for each period of 24 hours that the dog is impounded, where the dog is destroyed by order of the court is	25.00	(25.00)
The fee for a certified copy of the certificate of registration is	2.00	(2.00)
The fee for viewing the register is	13.00	(13.00)
