DETERMINATION (OF FEES)

NO. 126 OF 1994

EXPLANATORY STATEMENT

This instrument revokes all existing fees determinations under the Motor Traffic Act 1936, namely:-

Determination No. 54 of 1994 published in the ACT Special Gazette No. S125, of 27 June 1994

This Determination sets fees for the purpose of the Motor Traffic Act 1936 and has the effect of amending fees payable for transactions which relate to number plates. Set out below for easy reference are the amended fees (and previous fees) which apply to the transactions relating to number plates.

These amendments are required for the following reasons;

FEE FOR THE REMAKE OF NUMBER PLATE FEE WITH INTERIM PLATES

Prior to the introduction of TRIPS, the fee for this transaction was calculated by combining the remake of a number plate fee (\$22.00) with the replacement of lost or destroyed number plate fee (\$22.50). This principle was adopted during the specification and design of TRIPS. When the fee for this function is determined differently to the sum of the above mentioned fees, system complications occur as a rounding factor comes into play. To rectify this problem the fee for the remake of number plates with interim plates must be increased by 50 cents.

FEE FOR THE EXTENSION OF THE TERM OF RESERVE RIGHTS TO A NUMBER PLATE

In May 1993 (Brief US1817), the former Minister for Urban Services, Mr Terry Connolly reduced the fee payable for granting the right of a special number plates from \$26.00 per month (minimum two months) to \$7.00 per month. It was intended to reduce the extension of the right to a number plate fee as well but at the time was overlooked. It has now come to the attention of Transport Regulation that these two differing fee amounts are causing some complications on TRIPS (approximate modification cost - \$2000). To rectify this problem the fees are being brought into line.

REMAKE OF SPECIAL NUMBER PLATES - 'A' SERIES

The fee for the remake of 'A' series number plates was originally determined at \$144 per set. This was in fact incorrect and should have been determined as \$144 per plate. As these plates are expensive and quite ofte only one is damaged, it was decided to retain the option of buying a single plate. These number plates cost Transport Regulation \$108.20 per plate to remake and we would be losing revenue if we continue to charge the current fee.
