MOTOR TRAFFIC ACT 1936

DETERMINATION OF FEES

Under Section 217A of the Motor Traffic Act 1936, I REVOKE, with effect from 2 January 1990, the determination of fees under Section 163C(2) of the Act and DETERMINE, that the determined fee for the issue of a parking voucher from a voucher machine located at a site specified in the Schedule shall be the amount specified in the Schedule in relation to that site.

I SPECIFY, that for the purposes of Subsection 163C(1) of the Act, the period in relation to a voucher machine located at a site specified in the Schedule shall be the period specified in the Schedule in relation to that site.
