




All that land in the Australian Capital Territory being New South Wales crown road reserve within the parcel boundary of Block 51 in the District of Coree shown in a thick black line on plan number 1 annexed hereto; and a New South Wales road reserve within parcel boundaries of Block 99 in the District of Tennent shown in a thick black line on plan number 2 annexed hereto; and part of the old alignment of the Monaro Highway road reservation in the District of Tuggeranong shown in a thick black line on plan number 3 annexed hereto; and part of the part of the road 30.48 wide along the southern boundary of Block 64 in the District of Majura and shown in a thick black line on the plan number 4 annexed hereto - this section of road has been included as part of the area of Canberra Airport, an alternative road has been constructed and open to the public along the northern boundary of Canberra Airport as shown in hatched on the plan number 4 annexed hereto.






