BUSINESS FRANCHISE (TOBACCO AND PETROLEUM PRODUCTS) ACT 1984

DETERMINATION OF FEES

NO 62 OF 1990

Under section 44A of the Business Franchise (Tobacco and Petroleum Products) Act 1984 (the Act) with respect to relevant periods that commence on or after 1 September 1990, I REVOKE all previous determinations and make the following determination:

For the provisions of the Act listed in Column 1 of Table 1, the determined amount per litre for the fuel described in Column 2 of Table 1 shall be the amount per litre set out in Column 3 of Table 1 in relation to those provisions.
