

GOVERNMENT NOTICES

Pesticides Act 1989

Special conditions apply to all space spraying of public, industrial and commercial premises

- 1. Prior to carrying out space spraying the company or person proposing to do the spraying must provide the following information to the ACT Fire Brigade Control Room (Tel. 295 5711).
 - (a) Name of the company or persons.
 - (b) Telephone number of the company or persons.
 - (c) Address of premises to be treated.
 - (d) Date and time for commencement and completion of treatment.
 - (e) Pesticide which will be used.
 - (f) Period of time for which access to the treated area is restricted.
- Before commencing treatment, signs displaying the information required under 1(a) to (f) above are to be affixed to all access doors to the treated area.
- 3. For the purposes of this notice space spraying is defined as the application of a pesticide listed below in a confined space by means of misting, fogging or the release of an pesticide aerosol or smoke canister.

Subject to the Administrative Appeals Tribunal Act 1989, an application may be made to the Tribunal for a review of the decision to issue this notice. Except where subsection 26(11) of that Act applies a person whose interests are affected by that decision may request a statement pursuant to section 26 of that Act.

Failure to comply with the above conditions is an offence under Section 52(2) of the Pesticides Act 1989.
