### DECLARATION

#### INTERIM PLANNING ACT 1990

#### NCDC POLICY VARIATIONS

Under Section 51 (1) (c) of the Interim Planning Act 1990, we DECLARE that Section 51 of the Act is to apply to each of the eleven areas of land described in the Schedule below. Each area of land is affected by a draft Variation to an NCDC Policy which the Interim Territory Planning Authority, prior to the commencement date of the Interim Planning Act 1990, had:

- (a) submitted the draft Variation to Policy for that NCDC Policy to the National Capital Planning Authority; and
- (b) published a notice in the Gazette and in the principal daily newspaper published and had circulated in the Territory inviting interested persons to make written comment within a period specified in the notice.

These draft Variations to Policy had been submitted by the Interim Territory Planning Authority to the National Capital Planning Authority and released for public comment at the end of the transition period under the ACT (Planning and Land Management) Act 1988, however they had not been submitted to the ACT Executive for approval.




- (a) submitted a copy of the draft Variation for that NCDC Policy to the National Capital Planning Authority; and
- (b) published a notice in the Gazette and in the principal daily newspaper published and circulated in the Territory inviting interested persons to make written comment within a period specified in the notice.






