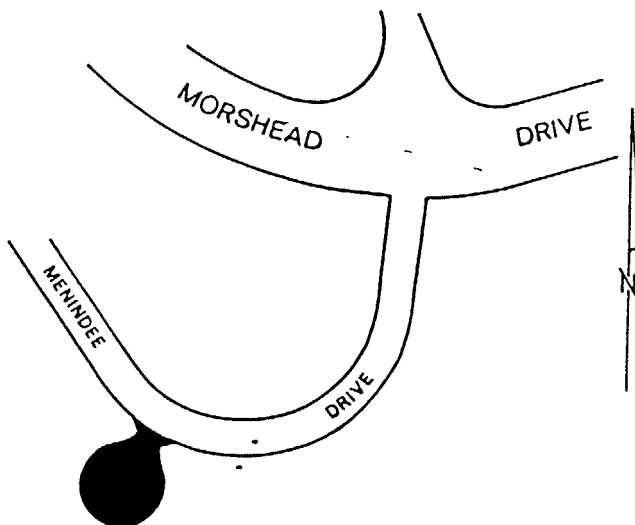

Plan No. 1 The constructed road which provides access to Block 13 Section 33 in the Division of Barton in the District of Canberra Central.

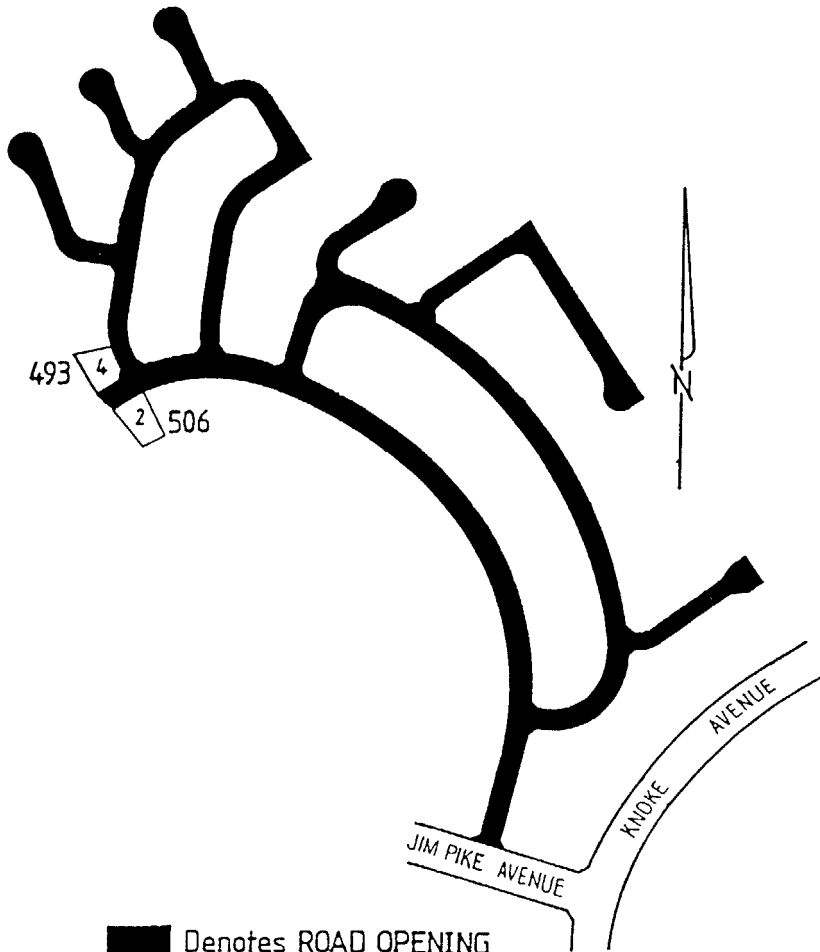
Plan No. 2 The road layout within Sections 493 to 505 in the Division of Gordon in the District of Tuggeranong.

Division of GORDON



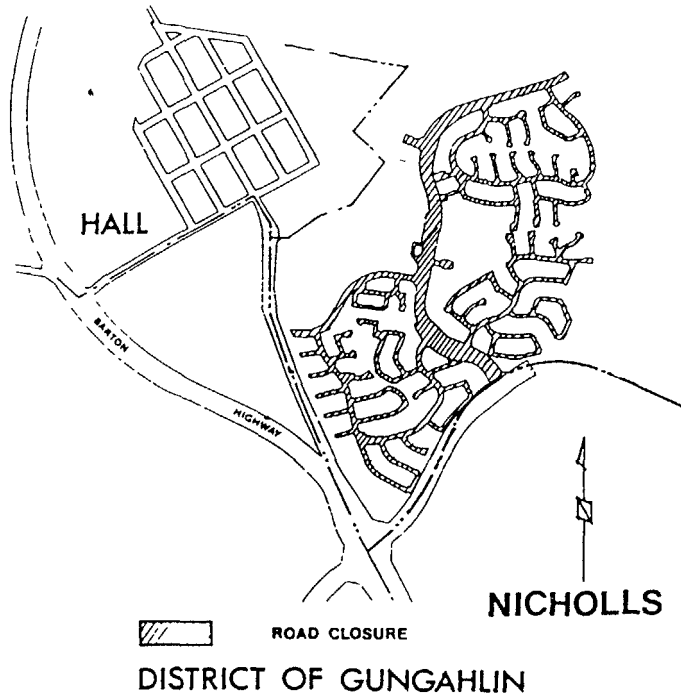

DRAFT TERRITORY PLAN

NOTICE

Introduction

Under section 19 of the *Land (Planning and Environment) Act 1991*, ("the Land Act") before submitting a draft Plan variation to the Executive for its approval, the ACT Planning Authority is required to publish a notice stating that the draft Plan variation and the background papers are available for public inspection, purchase, and comment.

The draft Plan variation to which this notice refers was previously published under the title "Draft Territory Plan". The Draft Territory Plan was made available for public inspection, purchase and comment on two previous occasions, the first commencing on 24 October 1991, and the second on 22 February 1992. Under this present notice the Draft Territory Plan is available for public inspection, purchase, and comment for a period of one month in accordance with the dates and conditions set out below.

It is intended that after this period of public consultation and review by the Authority, the revised draft Plan variation will be submitted to the ACT Executive. If approved, the Plan will be substituted for those policies of the former NCDC which, under Commonwealth law are presently required to be taken as part of the Territory Plan. These policies (presently referred to as "The Territory Plan") will be revoked by the new Plan.

Public Inspection

The draft Plan variation and background papers are available for public inspection and purchase during the period beginning on 19 August 1992 and ending on 17 September 1992.

Copies of the draft Plan variation and the Planning Report containing the background papers may be inspected at libraries of the ACT Government Library Service at Belconnen, Civic, Dickson, Erindale, Kingston, Kippax, Tuggeranong and Woden. The documents may also be inspected during office hours at the ACT Planning Authority, or at the Shopfront, Department of the Environment, Land and Planning, both of which are located at 220 Northbourne Avenue Braddon.

Copies of the documents may also be purchased from the Shopfront. Cost of the draft Plan variation and Planning Report is \$10 00 each.

Invitation to Interested Persons to Comment

Interested persons are again invited to submit written comments about the draft Plan variation to the Authority. Comments must be submitted during the period commencing 19 August 1992 and ending on 17 September 1992, and be addressed to:

If you have already submitted comments on the draft Territory Plan these will be taken into account when the draft plan is revised. Any further comments you may like to submit will be welcome.

Effect of Draft Plan Variation

In accordance with section 9 of the Land Act, the Territory, the Executive, a Minister or a Territory

authority shall not do any act or approve the doing of any act that-

- (a) would be inconsistent with the Plan if it were varied in accordance with the draft Plan,  
or
- (b) is inconsistent with the Plan;

during the period commencing on 19 August 1992 and ending 20 August 1992.

Section 11 of the Land Act has no effect for this draft Plan.
