STREET NOMENCLATURE

DIVISION OF NICHOLLS: SPORTSMEN AND WOMEN

NAME	ORIGIN	SIGNIFICANCE
ANNE CLARK AVENUE	Anne Clark (1903-1983)	She was one of the founders of the All Australian Netball Association and served five terms as its president. She was also president of the NSW Netball Association from 1949 to 1978. In 1931 she was awarded the AA Umpires Badge the ultimate achievement for umpires in Australia. She was instrumental in bringing about the separation of the ACT from the NSW Association. In 1975 she was awarded the BEM for services to sport.
LEXCEN AVENUE	Ben Lexcen (1936-1988)	Yacht Designer/ Sportsman. Designer of "Australia II", winner of America's Cup.

NAME	ORIGIN	SIGNIFICANCE
LINN STREET	Thomas Linn (1891-1961)	He played first grade tennis for East Torrens 1916-1936. He was Auditor South Australia Lawn Tennis Association, 1921-32, Treasurer 1932-49, Vice President 1949 and President 1959-61.
MASSIE PLACE	Hugh Massie (1854-1938)	A magnificent right forcing batsman, he played nine test matches for Australia. At Oxford on 1882 he thrashed the University's bowling for 206 in three hours. During his first class career 1877-95 he scored 2,485 runs.
DOOLAND COURT	Bruce Dooland (1923-1980)	An extremely gifted batsman and bowler, he played three test matches for Australia between 1945-48. He then played county cricket for Nottinghamshire until 1956. During his first class career he made 714 runs and took 1,016 wickets. He also represented Australia at baseball.



STREET NOMENCLATURE

DIVISION OF NICHOLLS: THEME SPORTSMEN AND WOMEN

NAME	ORIGIN	SIGNIFICANCE
ARTHALDO COURT	Don Arthaldo (1898-1965)	Born Walter Joseph Lyons, he was a sickly child but exercised and developed his small frame to massive proportions. After adopting the professional name Arthaldo, he became world famous as a circus strongman. For many years he was unchallenged as Australia's top strongman. He served in both world wars and was a skilled boxer, wrestler and cyclist.
COTTAM PLACE	John Cottam (1867-1897)	A right handed batsman, Cottam represented Australia once against England at Sydney, in 1886-87. During his first-class career (1886-90) he scored 273 runs.



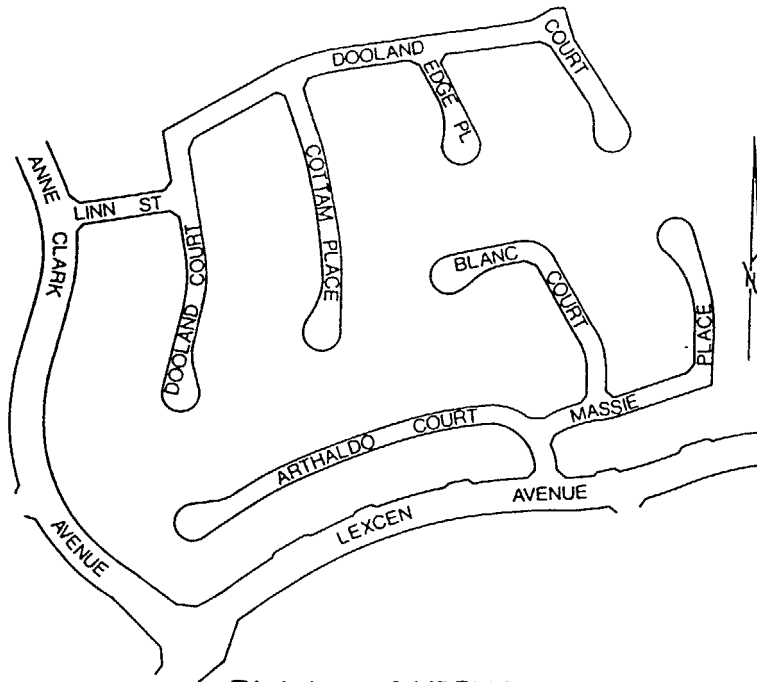


NAME	ORIGIN	SIGNIFICANCE
BLANC COURT	Gustave Blanc (1876-1959)	He developed his skill clearing bush on the family farm and won his first Woodchopping contest at Foster in 1899. He won his first World Championship in Tasmania in 1901. Before retiring from competition in 1911 he won many Australian, New Zealand and World Championships. He was a superb all-round athlete and played competitive cricket into his fifties.
EDGE PLACE	Selwyn Edge (1868-1933)	A champion cyclist, boxer and athlete, he became interested in motor tricycles and Australia before moving to Europe. In Europe he won many races and set a World 24 hour record in a six cylinder Napier car in 1907, covering 2545.5 kilometres. He later won Britain's first 24 hour race, averaging 104.6 kilometres an hour.




