
**PUBLIC ROADS ACT 1902 OF THE STATE OF NEW SOUTH WALES

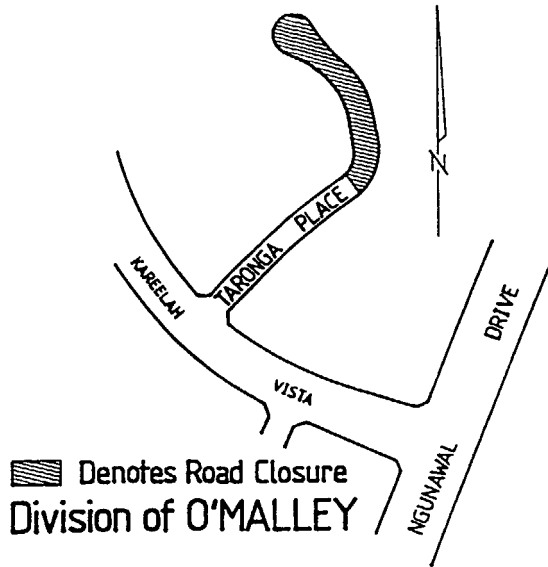
