For the purposes of section 11 of the Act the fee to accompany an application for the approval of a proposal for the subdivision of a parcel of land is:

- (a) where the applicant does not intend to apply for approval under section 16 of the Act before the completion of building works on the parcel
 - (i) where the number of units proposed does not exceed fifty 1,600 plus 110 for each unit in excess of 4 units
 - (ii) where the number or units proposed exceeds fifty 6,600 plus 100 for each unit in excess of 50 units

For the purposes of Section 16 of the Act, the fee to be paid prior to approval for sub-division is given, where the applicant seeks approval before the completion of building works on the parcel, except when the application under Section 11 was accompanied by a fee calculated in accordance with Item 1 (b).	420 plus 10 for each unit in excess of 4 units
