# KINGSTON SECTION 25 BLOCKS 4-6 AND THE GUIDELINES FOR REDEVELOPMENT OF KINGSTON/GRIFFITH

The ACT Planning Authority is inviting comment on a draft Variation to the Territory Plan for Kingston Section 25 Blocks 4-6 and changes to the Guidelines for Redevelopment of Kingston/Griffith.

The proposed development of Kingston Section 25 Blocks 4-6 includes:

- . 85 residential units
- . 1330m<sup>2</sup> commercial space
- . 86 publicly available parking spaces, and
- . 154 car parking spaces for the residential and commercial development.

The buildings are proposed to be 3 and 4 storeys in height with some basements.

The variation to the Guidelines for Redevelopment of Kingston/Griffith will remove the possibility of further tower blocks in the area.

Copies of the draft Variation:

- may be inspected at libraries of the ACT Government Library Service at Belconnen, Civic, Dickson, Erindale, Kingston, Kippax, Tuggeranong and Woden during normal opening hours; and
- may be inspected at, or obtained free of charge from, the Shopfront at John Overall Offices, 220 Northbourne Avenue, Braddon, during normal office hours from Monday 23 August 1993 to Friday 11 September 1993.

This draft Variation is to have interim effect under the provision of section 9 of the Act for the "defined period".

This is proposed to be done as soon as practicable after the closing date, therefore written comments must be received by Monday 13 September 1993.
