DETERMINATION OF FEES

DETERMINATION NO. 169 OF 1993

UNDER Section 217A of the Motor Traffic Act 1936, I revoke all previous determinations of fees so far as they are payable for the purposes of Section 163C(2) of the Act and relate to those car parks specified in Page 1 and Page 2 of the Schedule, and

I DETERMINE that the fee payable for the issue of a parking voucher from a voucher machine located at a site specified in the Schedule shall be the amount specified in the Schedule in relation to that site

UNDER Section 217A of the Motor Traffic Act 1936, I DETERMINE that the fee payable for the issue of a parking voucher from a voucher machine located at the site specified in Page 3 of the Schedule shall be the amount specified in the Schedule in relation to that site

UNDER Section 163C(3) of the Act, I SPECIFY that, for the purposes of Section 163C(2) of the Act, the period in relation to a voucher machine located at a site specified in the Schedule shall be the period specified in the Schedule in relation to that site
