SCHEDULE

Fees Applying to Waste Disposal

Definitions

"Household Waste" means waste from residential premises generated by domestic activity.

"Industrial and Commercial Waste" means waste generated, collected, transported or disposed of as part of an industrial or commercial activity. This includes waste from offices and professional premises.
