

Plan No. 1: Part of the road known as Goyder Street adjacent to Block 5 Section 100 in the Division of Narrabundah in the District of Canberra Central.





Plan No. 1: Part of the road known as Gold Creek Road which falls within Section 1 in the Division of Nicholls in the District of Gungahlin.


Plan No. 2: Part of the road known as Barton Highway in the Division of Nicholls in the District of Gungahlin.

Plan No. 3: Old NSW roads that lie within the proposed Divisions of Amaroo and Moncrieff in the District of Gungahlin




DIVISION OF NICHOLLS
