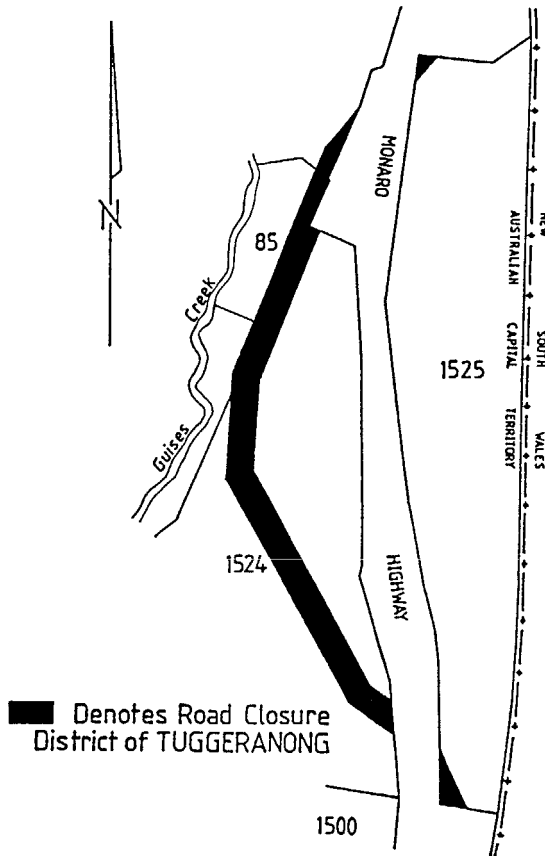

Plan No. 1: Part of old New South Wales road within the boundaries of Blocks 85, 1524 and 1525 in the District of Tuggeranong.

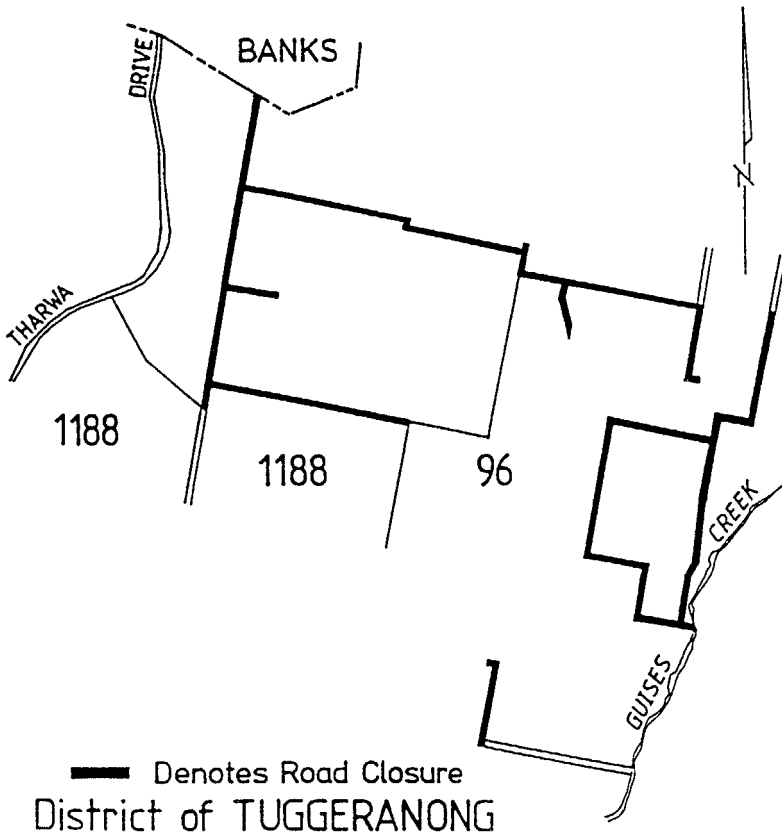
Plan No. 2: Old New South Wales roads north of Block 1188 and within Block 96 in the District of Tuggeranong.
