### Restricted Information

The Minister may, pursuant to s.82 of the *Land (Planning and Environment) Act 1991*, declare that a place is a place subject to restrictions on the public disclosure of information. Restricted information may not be published without the written approval of the Heritage Council, provided under s.84 of the Act.

Consistent with the provisions dealing with restrictions on the release of information, 'published' means that a person can not make any of the restricted information or material available to either the general public or to any person by any means. Significant financial penalties apply for the for the unauthorised release of any restricted information about an Aboriginal Place.

Places in the list above and identified with an asterisk (\*) are subject to restrictions about the release of information per s.82 of the Act.

### Effect of inclusion in an interim Register

Pursuant to Section 55 of the *Land (Planning and Environment) Act 1991*, the interim Heritage Places Register has effect as if it were the Heritage Places Register.

The inclusion of a provision about a place of heritage significance into the interim Heritage Places Register means that during the defined period the Territory, the Executive, a Minister or a Territory authority shall not do any act, or approve the doing of any act, which would be inconsistent with the interim Heritage Places Register.

The 'defined period' referred to above means the period commencing on the date of publication of this notice and terminating on the expiration of the day before:

- the interim Heritage Places Register is revised by the Council under s.62;
- the corresponding draft Plan variation is withdrawn by the ACT Planning Authority;
- the Executive revokes its approval of the corresponding Plan variation;
- the corresponding Plan variation is rejected by the ACT Assembly, or withdrawn by the Minister under s.29.

### Review of Decision

Subject to Part VIA of the *Land (Planning and Environment) Act 1991*, a person whose interests in relation to land are affected may apply to the Land and Planning Appeals Board for a review of the above decision of the Heritage Council to include a provision, in respect of a place listed above, in the interim Heritage Places Register.
