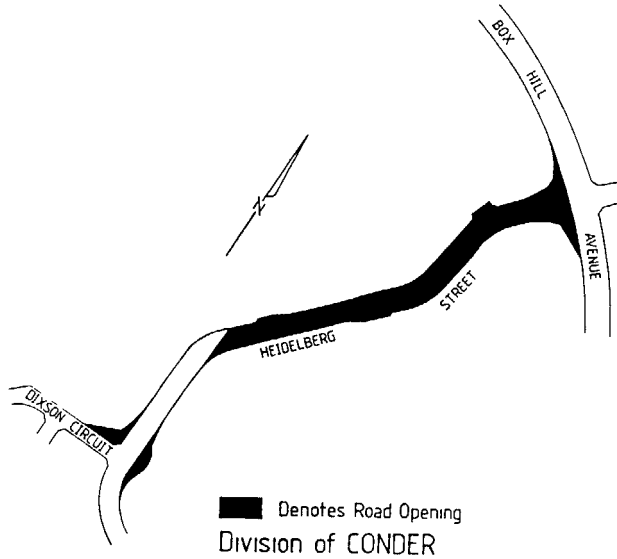



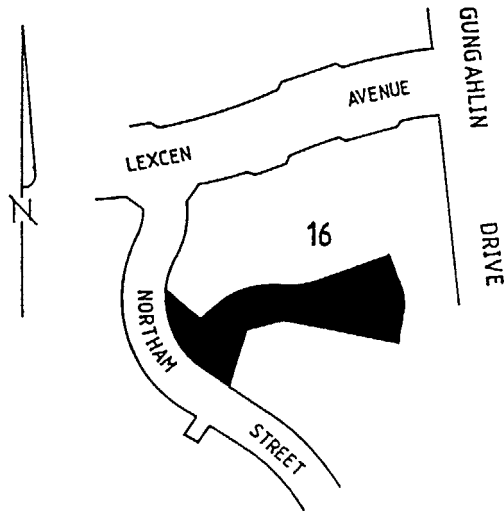

Plan No. 3 The road known as Earle Place within Section 43 in the Division of Page in the District of Belconnen.

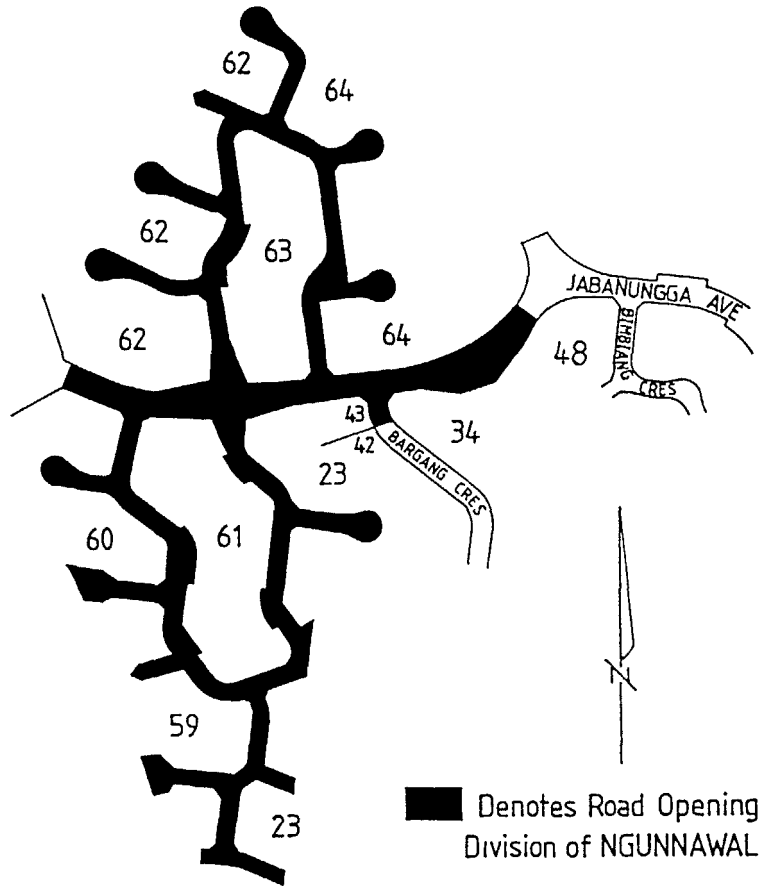


 Denotes Road Opening

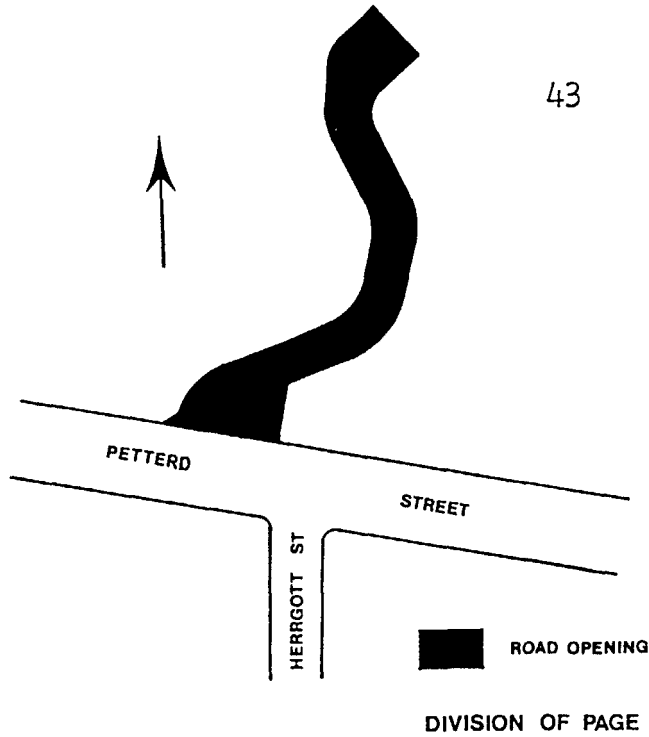
