



NOISE CONTROL ACT 1988

EXEMPTION NOTICE

No.002/96

Under Subsection 16(2) of the Noise Control Act 1988, I exempt, EXHIBITION PARK IN CANBERRA from the provisions of section 12 of the Noise Control Act 1988 between the hours of 10:00am and 5:00pm on the 4 FEBRUARY 1996 in respect of noise emitted from a motorsport event to be conducted on the Harness Racing Track, at Exhibition Park In Canberra, on Flemington Road, Mitchell in the Australian Capital Territory.

Provided that the emitted noise level shall not exceed 15 dB(A) above the background noise level at the nearest and/or most affected residence.

Subject to the Administrative Appeals Tribunal Act 1989, an application may be made to the Administrative Appeals Tribunal for a review of the decision to which this notice relates.

Except where subsection 26(11) of the Administrative Appeals Tribunal Act 1989 applies a person whose interests are affected by the decision may request a statement pursuant to Section 26 of the Act.

Computers and peripherals (purchase and lease); electronic office machines (see also Code 16), satellites, radio and television transmitting equipment, television cameras, picture tubes and studio equipment; navigational aids, semi-conductors, telephones and switch-boards; X-ray equipment, printed circuit boards

Industrial Machinery and Equipment (19)

Agricultural and industrial machinery; material handling equipment, machine tools, saw blades, verner calipers, jigs, dies; commercial heaters and coolers, outboard motors, mechanical typewriters

Leather, Rubber, Plastic and Manufactured Good NEC (20)
