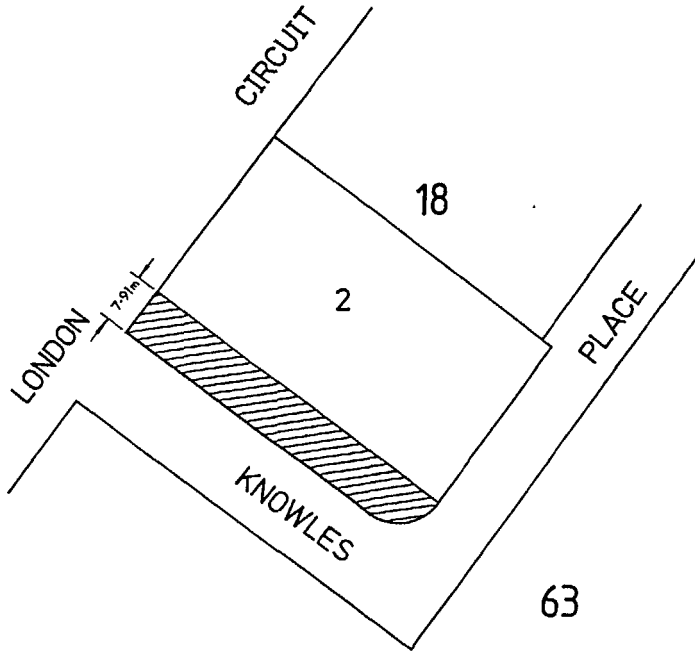

Plan No. 2: Part of the road known as McDonald Street adjacent to Hindmarsh Drive in the Division of Chifley in the District of Woden Valley.

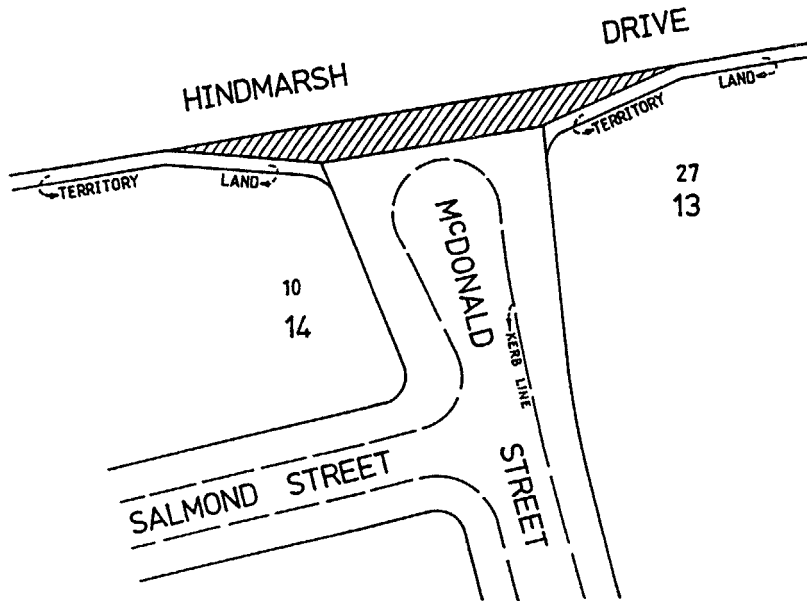

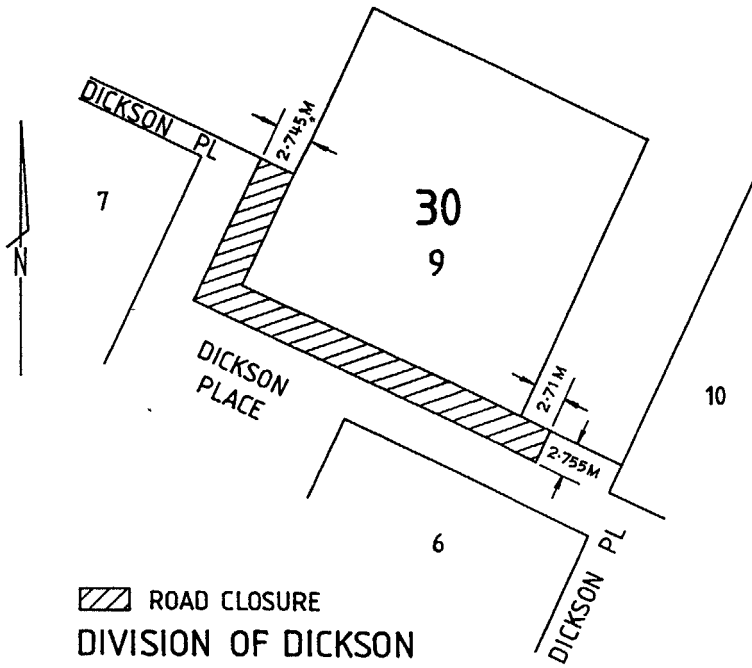
