**INVITATION TO COMMENT ON IMPLEMENTATION PLAN NO.21 FOR
THE HUGHES AND GARRAN TRAFFIC MANAGEMENT SCHEME, STAGE 2**

The Construction and Management Maintenance Service of the Department of Urban Services has submitted to the ACT Planning Authority an Implementation Plan for Stage 2 of the Hughes and Garran Traffic Management Scheme. Stage 1 of the works was implemented in June 1995.

Stage 2 involves the installation of traffic calming devices on Kitchener, Kent, Groom and Wisdom Streets in Hughes, and Palmer Street and Gilmore Crescent Garran.

The Traffic and Roads Section of the Department of Urban Services conducted an evaluation of the effects of the Stage 1 works, and also conducted a consultation exercise on the Stage 2 proposals, in September 1995.
