**DRAFT VARIATION NO.42 TO THE TERRITORY PLAN
MINOR CORRECTIONS TO THE RESIDENTIAL LAND USE POLICIES**

The ACT Planning Authority is inviting comment on draft Variation No.42 to the Territory Plan for Minor Corrections to the Residential Land Use Policies.

The draft Variation proposes to make a number of minor corrections to the Residential Land Use Policies in the Territory Plan:

- . to clarify original policy intentions where they are not explicitly stated in the Plan or where ambiguity is present;
- . to correct minor oversights and omissions; and
- . to correct typographical errors.

The draft Variation includes amendments to the Territory Plan Map and the Written Statement affecting sites in Belconnen, Hawker, Scullin, Kambah, Barton, Isabella Plains, Dunlop, Yarralumla and Red Hill. Copies of the draft Variation:

- . may be inspected at libraries of the ACT Government Library Service at Belconnen, Civic, Dickson, Erindale, Griffith, Kippax, Tuggeranong and Woden during normal opening hours; and
- . may be inspected at, or obtained free of charge from, the Shopfront at John Overall Offices, 220 Northbourne Avenue, Braddon, during normal office hours.
