Revised Quality Assurance Requirements on Capital Works

As announced by the Minister for Urban Services, Tony De Domenico, a revised Quality Assurance program is to be implemented on ACT Government construction projects

From 1 January 1997, Preliminary Second Party Certification will be required for Building and Construction contracts, including trade package contracts over \$500,000

From 1 July 1997, Substantial Second Party Certification will be required for Building and Construction contracts, including trade package contracts over \$500,000 and also for consultancies and project/construction/works management engagements on projects over \$50,000 and studies with a fee value over \$10,000

From 1 October 1997, Preliminary Second Party Certification will be required for Building and Construction contracts, including trade package contracts between \$100,000 and \$500,000
