From 1 January 1997, Preliminary Second Party Certification will be required for Building and Construction contracts, including trade package contracts over \$500,000.

From 1 July 1997, Substantial Second Party Certification will be required for:

- Building and Construction contracts, including trade package contracts over \$500,000, and
- also for consultancies and project/construction/works management engagements on projects over \$50,000 and studies with a fee value over \$10,000

From 1 October 1997, Preliminary Second Party Certification will be required for Building and Construction contracts, including trade package contracts between \$100,000 and \$500,000.
