INVITATION TO COMMENT ON IMPLEMENTATION PLAN NO.35 FOR
INTERNAL ROADS AND SERVICES TO ENABLE THE SUBDIVISION OF LAND
FOR THE LANYON MARKET PLACE (CONDER GROUP CENTRE)

Construction and Maintenance Management Service, of the Department of Urban Services, is proposing Internal Road and Services works to enable the subdivision of land for the Lanyon Market Place (Conder Group Centre).

The proposed works include:

- Roads and pathways required to provide connections to Tharwa Drive, Box Hill Avenue and Heidelberg Street.
- Pathways to provide connections to the existing pedestrian network.
- Two bus laybys in Box Hill Avenue
- Sewer, drainage, water supply, Telstra and gas services required for the proposed shopping centre and other blocks to be handed back to the Territory.
