**INVITATION TO COMMENT ON IMPLEMENTATION PLAN NO.39 FOR  
MODIFICATIONS TO CITY WALK**

The Canberra Places, Civic Taskforce has submitted an Implementation Plan for works to provide urban design improvements to the existing entrance to City Walk from the City Bus Interchange.

The proposed works include:

- Demolition of the ACTION Control Tower;
- Demolition of the public toilet block;
- Demolition of part of the planter box in front of the Police kiosk;
- Relocation of ACTION to either the Una Porter Building or the Saraton Building;
- Provision of new public toilet facilities in locations yet to be determined. This will be the subject of a separate application;
- Reconstruction of the access way for service vehicles entering and leaving the service court behind Garema Court, the Saraton Building and other buildings in the block bounded by East Row, Petrie Plaza and City Walk;
- Retention of existing provision for vehicles servicing shops in the Una Porter Building fronting City Walk;
- Provision of access for vehicles entering and leaving the carparking area in the basement of Garema Court; and
- All necessary ancillary works.
