MILK AUTHORITY ACT 1971

The Milk Authority of the Australian Capital Territory, in pursuance of Section 16A of the Milk Authority Act 1971, hereby fixes and declares

- 1 This notice takes effect on Sunday, 20 July 1997.
- 2 All Gazette notices published prior to the date of this notice pursuant to Section 16A of the Milk Authority Act 1971 are hereby revoked
