HERITAGE PLACES REGISTER

The Planning and Land Management Group (PALM) of the Department of Urban Services (incorporating the ACT Planning Authority) is proposing two draft Variations to the Territory Plan which, if adopted, would add:

Lennox House Complex, the Uniting Church at Reid and Tharwa Bridge, to the Heritage Places Register (draft Variation No. 66); and

Aboriginal Rock Art Sites in Namdgi National Park, Cuppacumbalong Woolshed Complex, Duntroon Dairy at Campbell, Duntroon Woolshed at Pialligo, Gungahleen School at Lyneham, Manuka Swimming Pool at Griffith and Tocumwal Housing Precinct at O'Connor, to the Heritage Places Register (draft Variation No. 79).

These draft Variations are to have interim effect under the provision of section 9 of the Land (Planning and Environment) Act 1991 for the "defined period".
