A DECISION OF THE NURSES BOARD OF THE A.C.T. IN THE MATTER OF ANNA MARIA FORSTER, D.O.B. 6.2.1971 REGISTERED NURSE, REGISTRATION NO. 5357

The Nurses Board of the ACT (the Board) held an Inquiry into the conduct of Ms Anna Maria Forster, Registered Nurse, under section 66 of the *Nurses Act 1988 (*the Act).

The Board on 7 August 1998 reprimanded Anna Maria Forster, under paragraph 64(1)(a) of the Act and imposed the following condition on her registration under paragraph 64(1)(c) of the Act: that

'Anna Maria Foster not provide nursing to persons under 16 years of age until such time as she has successfully completed a graduate certificate course in paediatric nursing or a post graduate diploma in paediatric nursing'.


