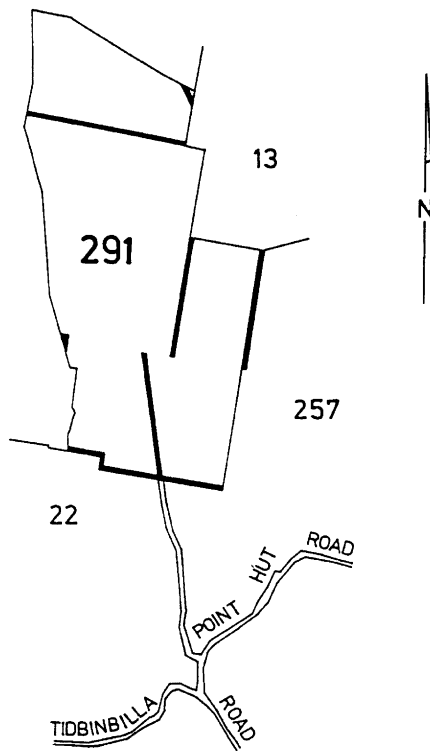

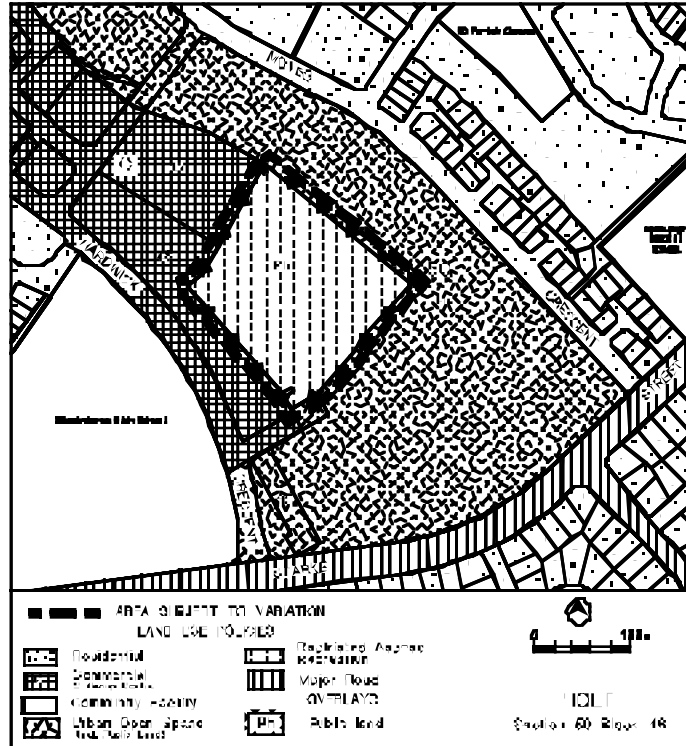

DRAFT VARIATION NO.124 TO THE TERRITORY PLAN CHARNWOOD SECTION 94 BLOCK 1 - FORMER CHARNWOOD HIGH SCHOOL

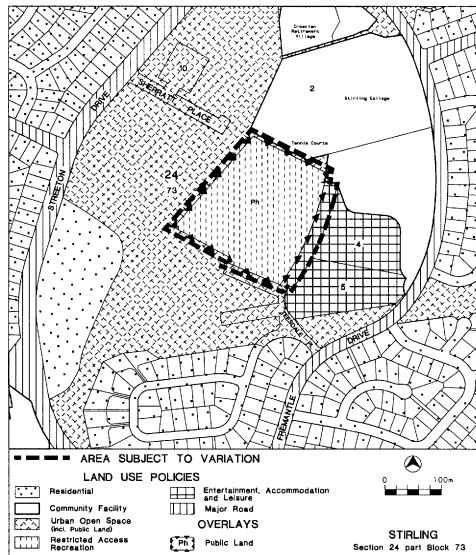
Two draft Variations to the Territory Plan have been prepared by the Planning and Land Management Group (PALM) of the Department of Urban Services (incorporating the functions of the ACT Planning Authority). These relate to the Holt and Stirling District Playing Fields and the Former Charnwood High School.

Draft Variation No.115, for the Enclosure of Grounds at Holt and Stirling District Playing Fields, proposes to vary the land use policy for the sites at Section 50 Block 46 Holt (part of the Holt District Playing Fields) and a ground at Section 24 Block 73 Stirling (part of the Stirling District Playing Fields), from Urban Open Space to Restricted Access Recreation. At the same time the Public Land category would be varied from Urban Open Space(Pe Overlay) to Sport and Recreation Reserve (Ph Overlay). The draft Variation also proposes to make a minor adjustment to the boundary of the adjacent Entertainment Accommodation and Leisure Land Use Policy in Stirling to include part of Teesdale Place.

The areas covered by the draft Variation are shown on the maps below.

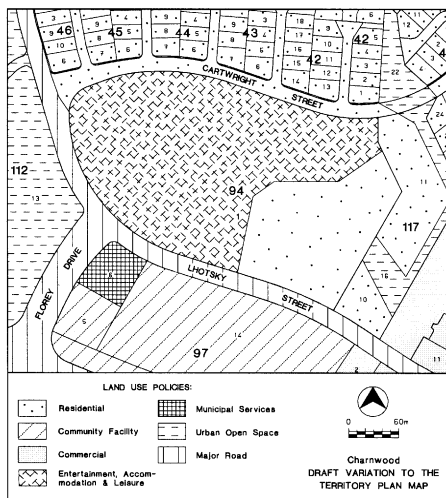

Draft Variation No.124, for the Former Charnwood High School at Section 94 Block 1 Charnwood, proposes to change the Land Use Policy from Community Facility to part Residential and part Entertainment, Accommodation and Leisure.

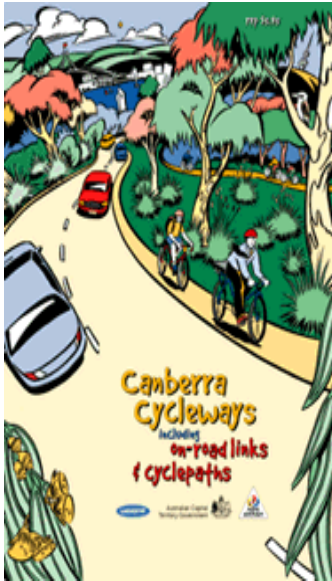
