#### **HOTEL SCHOOL ACT 1996**

Pursuant to Section 30 of the *Hotel School Act 1996*, the Board of Management of the Australian International Hotel School ("School") determines that the following fees are payable, from 1 January 1999, by new students commencing the Bachelor of Hotel Management, or equivalent course, conducted by the School.

#### **National Students**

The following categories of applicants are eligible for national student fees:

- Australian Citizens
- Permanent residents of Australia
- New Zealand Citizens\*

National Student fees comprise -

Tuition Fees	\$37,925
plus once only enrolment fee	\$2,000

\* plus Overseas Student Health Cover for New Zealand citizens as required by the Australian Government in advance for the first year.

The \$2,000 enrolment fee will be refunded to national students who:

- have resided in the Act for two or more years directly preceeding their date of application to the School.
- applicants whose parents/guardians have resided in the ACT for two or more years directly preceeding the applicant's date of application to the School.

#### **International Students**

International Students are students who do not meet the criterion for a national student. Fees for these students comprise -

Tuition Fees	\$44,075
Enrolment fee	\$ 2,000
International Student fee	\$ 1,500*

\* includes first year of Overseas Student Health Cover as required by the Australian Government.

#### **Payment Arrangements**

The standard payment arrangements are based on tuition fees being paid in advance for subjects taken each term.

Alternative payment arrangements on the following basis can be arranged:

- Monthly payments in advance based on 36 equal payments over three years of study. The first payment is due 14 days before the commencement of the course and a 5% administrative fee is applied .
- Term payments based on 9 equal payments made a month in advance which do not attract a discount or an administrative charge.
- Annual Payments based on three equal payments made a month in advance which attracts a 5% discount.
- A 5% administrative penalty per term will be applied where the payment schedule is not met.

#### **EXPLANATORY STATEMENT**

The Public Place Names Act 1989 provides for the naming of divisions and, in particular, section 4 empowers the Minister, by notice published in the Gazette, to determine the name of a division or public place.

Pursuant to section 5 of the Administration Act 1989, the Minister has delegated the power under the Public Place Names Act 1989 to name a division or public place to the Executive Director, Planning and Land Management Group, Department of Urban Services.

Section 27 of the Interpretation Act 1967 specifies that where an Act confers a power on a person to make an instrument then, unless the contrary intention appears, that person has the further power to amend the instrument.

This Instrument amends:

Instrument No. 8 published in Gazette No. S14 of 1 February 1993;  
Instrument No. 46 published in Gazette No. S92 of 31 May 1993; and
