LAND (PLANNING AND ENVIRONMENT) ACT 1991

NOTICE

The ACT Executive, pursuant to paragraph 26(1)(a) of the Land (Planning and Environment) Act 1991, approved on 14 September 1998:

- Variation to the Territory Plan No.66 entitled Heritage Places Register (Fourth Variation); and
